Osteopathy

The national health ministry of Germany has stated that the regulation of the osteopathic profession is presently adequate through the existing medical societies for physicians and the Heilprakitker organisations for osteopaths practising under this law. Physiotherapists, being trained as osteopaths, can only give osteopathic treatments under the scope of practice of their profession.

Despite this, osteopathy is a popular healthcare choice and treatment is increasingly being covered by most of the private and statutory health insurance companies.

Training in osteopathy is provided in full- and part-time university courses as well as full- and part-time courses run by private institutions. The duration and content of the education may differ from school to school, as there is currently no common curriculum recognised as the national standard. European common guidelines are being developed by the leading national associations for Osteopathy in Europe. Eventually these would serve as the future national standard.

The leading professional organisations and associations in Germany require a minimum of 1350 training hours for part-time education programs for physiotherapists. Currently two full-time universities of applied sciences in osteopathy exist, leading to BSc. and MSc degrees.

Statutes/Regulations:

There are presently no statutes or regulations defining the scope of practise of osteopathy in Germany. Regulations are currently being developed.
