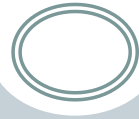

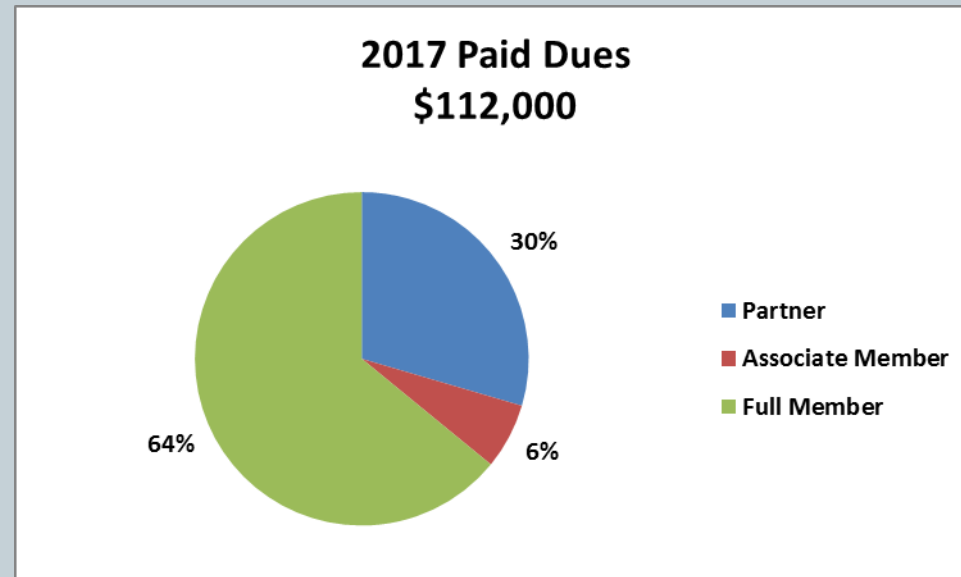

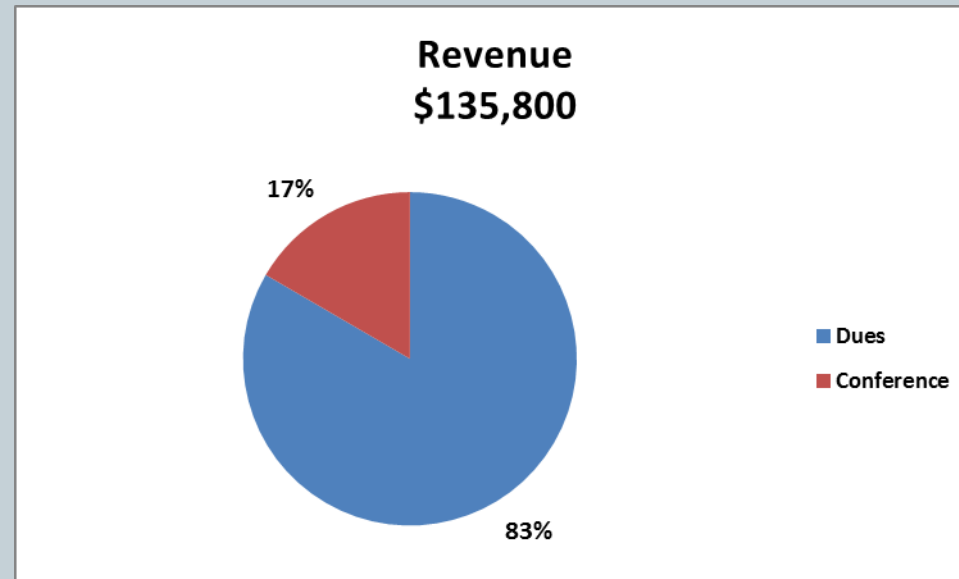

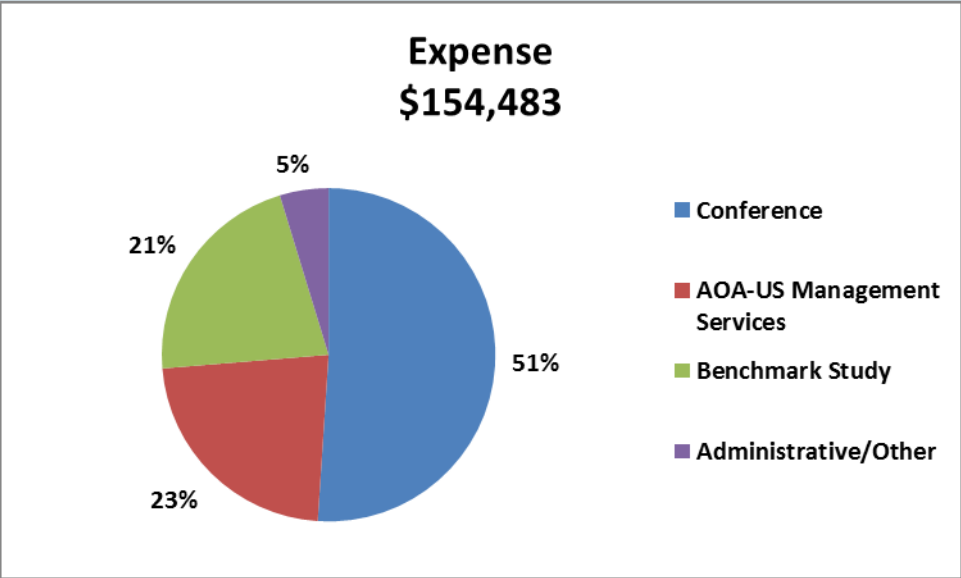
REVENUE 2017

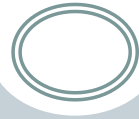

ELECTION PROCEDURE



- The OIA bylaws state that two (2) seats on the Board shall be allocated for the nominees of the osteopathic physician or osteopath organisation with the greatest number of members, and one (1) seat on the Board shall be allocated for the nominee of the organisation with the greatest number of members from the other stream of the profession.
- Dr Boyd Buser will fill the seat allocated to the largest Full member organisation (vacated by Dr Nichols), according to the bylaws.
- The remaining two (2) seats will then be filled by the election of two (2) representatives of the three (3) remaining candidates.

CANDIDATES' FORUM

BOARD ELECTIONS PROCESS



Procedure:

- Each delegation will be given one ballot for each of their allotted votes.
- Each delegation will check two names on each ballot.
- There can be a total of 23 votes for the two seats on the Board. The candidates who receive the largest number of votes will be elected.
- In the event of a tie, a re-vote will occur until there is one clear winner.
