



# World Health Organisation

- OIA leadership met with Dr Zhang at the World Health Assembly in Geneva in May
- Provided data from the Global Report 2 to Dr Zhang, which were published in the WHO Traditional Medicine Strategy, 2014-2023
  - Approved by WHO member states at the 2014 World Health Assembly
- Considered in a working relationship with WHO

# 2014 Membership

- Current Membership
- As of 1 October 2014, there are 77 members of the Alliance.
  - 10 Full members AOA, DAAO, DGOM, FSO/SVO, iO (formerly BOA),
     OA (formerly AOA-AU), OFSD, ONZ, SAGOM, VOD
  - 9 Associate members SBO-SBO, CFO, CSdO, JOF, NAO, RBrO, ROB, ROR, UNRO
  - o 58 Partner members − 32 schools, 20 national/regional organisations and 6 international organisations
- Since the Austin meeting, there have been 13 application.
  - o 7 applications have been approved
  - 4 applications were unsuccessful
  - o 2 applications are pending further review

# Secretary-Treasurer Report

- Memorandum of Understanding with AOA
  - Renewable on an annual basis; the Board agreed to raise the payment to \$25,000 in 2014 then \$5,000 per year to \$35,000 in 2016
- 2014 Membership fees: \$83,000
- Conference fees for Austin: \$21,000
- Reserve fund allocated for USD \$100,000

## **London Election Procedure**

- The OIA bylaws state that two (2) seats on the Board shall be allocated for the nominees of the osteopathic physician or osteopath organisation with the greatest number of members, and one (1) seat on the Board shall be allocated for the nominee of the organisation with the greatest number of members from the other stream of the profession.
- Dr Nichols will maintain the seat allocated to the largest Full member organisation, according to the bylaws.
- The remaining seats will then be filled by the election of two (2) representatives of the six (6) remaining candidates.
- Six (6) further seats on the Board will be filled by election at the AGM. No less than six (6) members of the Board shall hold a qualification that makes them eligible to practice as an osteopath or osteopathic physician.

# **Board Elections Process**

## Procedure:

- Each delegation will be given one ballot for each of their allotted votes.
- Each delegation will <u>check two names on each ballot</u>.
- There can be a total of 21 votes for the open seats on the Board. The candidates who receive the largest number of votes will be elected.
- In the event of a tie, a re-vote will occur until there is one clear winner.
